Board on Aging and Long-Term Care

Delete the volunteer ombudsman program.

Delete the ombudsman services for family care enrollees.

Child Abuse and Neglect Prevention Board

Reduce funding increases for the state plan for the prevention of child maltreatment.

Delete the attachment of the Board of the new Dept of Children and Families.

Health and Family Services

Health Care Quality Fund

Delete the health care quality fund.

Replace health care quality funding MA benefits with GPR.

Delete permanent endowment funding to the health care quality fund.

Delete the assessment on hospitals' gross revenues and MA rate increases for inpatient and outpatient hospital services.

Reduce MA benefits associated with the hospital assessment.

Delete the demonstration project to provide MA coverage to childless adults.

Reduce funding for tobacco use control grants.

Delete monies provided for colposcopic examinations.

Delete the funding increase for breast cancer and cervical cancer screening services under the Wisconsin well-woman program.

MA General

Delete all funding and statutory changes relating to BadgerCare Plus, except combining MA and BadgerCare benefits appropriations.

Delete the repeal of the requirement that HIRSP design and administer a health care tax credit program.

Delete the increase reimbursement for certain non-institutional services provided to MA and BadgerCare recipients.

Increase the MA inpatient and outpatient hospital rates.

Delete the dental rate increase pilot project.

Increase the MA dental rate.

Modify JFC to require DHFS to contract with a transportation manager that would provide a single point of contact for MA and BadgerCare recipients who require non-emergency transportation services.

Modify JFC by paying for Medicare Part B with GPR.

Delete the family planning demonstration project.

Require DHFS to issue payment for at least 95% of proper provider claims for reimbursement under the MA, BadgerCare, and SeniorCare program within 30 days of receipt of the claims, and issue 100% of such claims within 45 days of receipt of the claims.

Require care management organizations that pay health care providers for services they provide to Family Care enrollees to issue payment for 95% of proper claims within 30 days and 100% of such claims within 45 days of receipt of claims.

Modify current law relating to county and tribal reimbursement for funeral and burial expenses on indigent individuals so a county or tribe would provide no reimbursement in cases where the total funeral and burial expenses exceed \$4,500 rather than \$3,500.

MA-Long Term Care

Delete the nursing home bed assessment and instead increase nursing home rates by approximately 5% in 2008-09 using GPR and FED.

Delete the Family Care expansion.

Delete \$250,000 annually from grants to organizations for technical assistance and planning services in support of family-centered managed care for children and long-term support needs.

Modify the training requirements for individuals who sell long-term care insurance.

Delete MA administration funds for the Board on Aging and Long-term Care.

Health

Reduce funding for vital records automation project.

Increase vital records fees.

Delete the increased funding to support community health centers.

Reduce funding for the state's HIV/AIDS program.

Delete one-time funding for an infant mortality project in Racine County.

Require DHFS to apply annually for federal abstinence education funds from the Title V State Abstinence Education Grant Program.

Modify current law pertaining to information and records retained by organizations and individuals who participate in the review or evaluation of services of health care providers.

Modify current law to include other relevant "medical" information for current treatment of individuals among the types of treatment of records that may be released without informed consent

Modify current law to permit health care providers to charge a fee of up to \$1.00 per record for medical records.

Specifies that a health care provider, health care facility, or employee thereof that reports in good faith or provides information, which is not expressly prohibited, is immune from any civil liability that may result from any act or omission in reporting.

Allow employers to offer additional forms of financial incentives to encourage or discourage employees' use of a lawful product.

Modify the state's family planning program.

DHFS and DCF - Children and Families

Delete the Department of Children and Families and Transfers from DHFS and DWD to the New Department.

Delete the annual appropriation to DHFS to distribute to community action agencies that support the skills enhancement program.

Delete the 5% uniform foster care rates increase effective January 1, 2008; retain the 5% rate increase effective January 1, 2009.

Delete making the food stamp employment and training (FSET) program voluntary; and delete transferring from DWD to DHFS.

Delete domestic abuse grant funding by \$706,600 in 2007-08 and \$567,100 in 2008-09; retain the increase in the domestic abuse surcharge from \$75 to \$100.

Delete the funding increase for post-adoption resources centers and the adoption exchange and adoption information center.

Delete annual appropriation to organizations in Milwaukee County that provide service to aid youth in making transition from foster care to independent living.

Delete the authorization use of income augmentation funds and excess federal revenues for tribal out-of-home care placements.

Decrease funding for the electronic Wisconsin statewide automated child welfare information system.

Decrease funding provided to support child care licensing activities.

Maintain funding to support the Bureau of Milwaukee Child Welfare, but reduce GPR funding and replace with PR funding.

Disability and Elder Services and Administration

Delete funding to the Quality Home Care Commission.

Delete the annual appropriation to DHFS for grants for organizations or groups to provide services for female prisoners and offenders from Milwaukee County and their children for reintegration.

Delete the provision that requires DHFS to annually allocate any funding the state receives in excess FED from the federal community mental health services block grant to community aids, the integrated services program, the consumer and family self-help and peer-supported programs, and protection and advocacy services. Retain the provision that modifies statutory references to funding for these programs to require (rather than permit) DHFS to provide annually the amounts specified in statutes.

Direct DHFS to modify the registry the Department maintains of persons who have satisfactorily completed the nurse's assistant, home, health aid, or hospice aide instructional program.

Delete the JFC transfer funding and staff for the Wisconsin Council on Developmental Disabilities from DHFS to the Dept of Children and Families.

Delete the creation of 1.0 unclassified division administrator position in DHFS for the division of the Division of Disability and Elder Services.

Delete the extension of 1.0 FED agency liaison project position to the Governor's Office.

State Operations Funding Reductions: \$2,288,800 in 2007-08 and \$3,811,700 in 2008-09.

Institutions

Delete funding for treatment-to-competency services.

Provide funding in 2007-08 to enable three state centers for the developmentally disabled to fully fund the cost of the bed assessment increase.

Provide 6.64 additional positions for the state centers for the developmentally disabled so that 17.56 positions, rather than 24.20 positions, would be deleted.

Require DHFS to issue a request for proposals to provide pharmacy management services for the Winnebago Mental Health Institute and for the Wisconsin Resources Center.

Insurance

Delete the transfer of \$175,000,000 from the injured patients and families compensation fund to the health care quality fund in 2007-08.

Modify current law to prohibit the Governor from introducing a budget that uses funds from the IPFCF.

Delete funding for an additional insurance financial examiner-in-chief position.

Require every health insurance policy to continue to cover a dependent student who ceases to be a full-time student because of a medically necessary leave of absence.

GENERAL GOVERNMENT AND JUSTICE

Administration

Delete provision creating an Office of Energy Independence.

Delete JFC provision providing for a records management position in DOA.

Eliminate Washington D. C. office.

Delete JFC provision providing annual grants to support administrative costs of the WTCS Foundation for operating the Dept of Defense excess property program.

Reduce funding for DOA for subsidizing a child care service; eventually eliminate authority to subsidize it.

Allow Joint Committee on Information Policy or Audit Bureau to review all executive branch IT projects.

Extend date for certain comprehensive planning requirements.

Direct DOA and UW System to convert biweekly payroll systems to monthly payroll systems.

DOA – Office of Justice Assistance

Delete funding and positions and creation of Bureau of Criminal Justice Research.

Delete provision transferring the administration of the youth diversion program from Corrections to OJA.

Delete \$900,000 from law enforcement officer supplemental grant program.

Delete program to provide state grant funding to organizations providing civil legal services to indigent persons.

Delete provision providing grant to the county that has the highest violent crime rate to fund preparation of presenting assessments of offenders.

Delete grant funding to the county that has the highest violent crime rate to enable the county to establish and operate a treatment alternatives and diversion from incarceration program.

Delete provision allowing OJA to allocate FED Byrne funding to an entity in Dane County for employment of a full-time youth court coordinator.

Delete office and transfer funding, staff and duties to the Departments of Justice and Military Affairs (homeland security grants)

Circuit Courts

Maintain current law and delete \$19.1 million for increased funding for circuit court support payments to counties.

Maintain current law related to state reimbursement to counties for court interpreter services.

Provide new Juneau County circuit court branch.

Compensation and Other Reserves

Reduce GPR compensation and other reserves by \$94.1 million; reserve remaining amounts for state employee compensation adjustments and any potential revenue losses based on Supreme Court decision in DOR v. River City Refuse Removal, Inc.

Corrections

Delete funding and 39 positions to restore security personal deleted as part of a general funding and position reduction in the 05-07 budget.

Delete funding and 50 correctional officer positions annually associated with utilization of overtime in adult correctional facilities.

Delete provision to expand the utilization of the earned release program.

Delete computer recycling program re-estimate.

In addition to report on segregation overcrowding at Prairie du Chien, direct department to evaluate need for expanding North Hall.

Make technical modification to GPS tracking of certain child sex offenders.

Modify JFC recommendations on sex offender registry fee.

Delete requirement department provide a state ID card to individuals released from prison who do not possess another form of state ID.

Delete requirement department assist offenders prior to release in applying for assistance under the FoodShare program.

Delete requirement department submit a report to JFC on impact of the treatment alternatives and diversion program on the 09-11 budget.

Delete provision providing funding for purchased services for offenders to expand community alternatives to revocation.

Delete funding to fully fund non-salary costs associated with 14.25 community corrections positions created in 2005 Act 25.

Delete provision to provide increased youth aids funding.

Delete provision directing department to submit a response to the audit of the effect of providing juvenile court jurisdiction for 17 year olds to the Audit Committee and JFC.

Delete \$1.6 million associated with inmate compensation for participating in education and program assignments.

Delete \$1.2 million associated with inmate compensation for inmates who wish to work or participate in education or program assignments but for whom no assignment is available.

Delete funding for inmate postage and writing materials.

Delete funding and 40 positions associated with corrections unit supervisor positions.

Delete funding for executive assistant salary and fringe benefits.

Delete \$25.2 million annually associated with administrative funding; restrict where deletions can be made.

Require department to solicit RFPs for contracting for Departmentwide health care services.

Modify current law to provide a prisoner's health care information can be released to certain correctional or county jail employees under certain circumstances.

Create language exempting certain correctional officers also certified as EMTs from annual certifications for CPR and AED training.

Include provisions of 2007 AB 226 to require child sex offenders, who are required to be monitored using GPS tracking, to utilize special registration plates that would have a chartreuse-colored background.

District Attorneys

Make Vernon County DA a full-time position.

Direct DOJ to provide funding for additional ADA positions in the following counties:
Chippewa and St. Croix.

Employee Trust Funds

Require non-represented classified and unclassified state employees, including UW faculty and academic staff, to pay first 5.0% of earnings as employee contributions to Wisconsin Retirement System.

Prohibit ETF Board from approving employee required contribution rates of less than 5% for general employees and state elected officials and executives.

Require, except for protective occupation employees, state employees to contribute 10% of the cost for state health insurance premiums for coverage beginning Jan. 1, 2008.

Provide funding for ETF's contribution to a joint contract that ETF and DHFS plan to enter into with the Wisconsin Health Information Organization to collect, analyze and publicly report certain health care claims information from insurers and administrators.

Provide that a participating employer in the WRS who is covered by the Municipal Employment Relations Act, may not pay the first 3\$ of earnings for an employee that is participating.

Delete provision providing, except for LTEs, the employer-required contribution toward health insurance premium of certain state employees would begin on the first day of the third month to the first day of the seventh month.

Employment Relations Commission

- Include provisions of 2007 AB 110 relating to authority of public employers to select group health insurance plans.
- Place restrictions on final offers under the Municipal Employment Relations Act.
- Authorize municipal employers to solicit bids to perform services currently performed by employees of the employer under certain circumstances.
- Delete provision related to disciplinary procedures for firefighters.

General Provisions

Eliminate 81.52 vacant GPR positions.

Include provisions of Assembly Sub. 1 to 2007 AB 31 relating to elimination of sick leave for legislators, justices and judges and all other state elected officials.

Include provisions of Assembly Sub. 1 to AB 170 relating to posting of legal notices on the Internet.

Allow abbreviated notices of ordinances, rules and orders by county, city, village or towns.

Modify current law related to collection of fines and forfeitures by counties.

Make changes affecting assignment of income and earnings for municipal court judgments.

Adopt provisions of 2007 AB 34 relating to garnishment of a minor's earnings and make additional changes.

Prohibit prisoners from initiating a John Doe proceeding under current law.

Make the sheriff's contracting to provide meals for inmates of the county jail a prohibited subject of bargaining if the contract would result in lower costs than if county employees provided the meals.

Require the sheriff to check the legal status of individuals who are charged with a felony or the offense of OWI and notify federal authorities if the individual is not legally in the U.S.

Include provisions of 2007 AB 260 on refusal or termination of employment of certain offenders.

Include provisions of 2007 AB 30 on refusal or termination of employment by educational agency of unpardoned felons.

Increase the penalty for exposing genitals or pubic area.

Create a civil cause of action for injuries caused by illegal drug use.

Include provisions if 2007 AB 35 to modify current law related to the privilege of self-defense.

Delete provisions designating June 14th as "Fighting Bob" LaFollette Day.

Government Accountability Board

Include provisions of 2007 SB 200, allowing an elector to require ID.

Include provisions of 2007 SB 201, restricting ballot printing in Milwaukee.

Beginning in 2008, eliminate the authority of an elector to vote straight party ticket, with exceptions.

Preclude utilization of employment compensations for political purposes.

Governor

Delete provision providing funds and 4 positions to assist in the development and implementation of policy initiatives in the Office of the Governor.

Justice

Delete provision modifying the imposition of the crime victim and witness assistance surcharge to civil offenses.

Delete provision related to crime victim compensation award funding.

Delete funding to law enforcement community policing grants program for Milwaukee for certain purposes.

Adopt provisions of Enrolled 2003 SB 8, providing a partial exemption of utility security system plans from the open records law.

Prohibit the DOJ from bringing or joining a nuisance lawsuit if the alleged activity is not in violation of a statute, rule, permit or ordinance.

Legislature

Require a \$6.3 million lapse from the legislature's appropriations.

Reduce legislative membership dues appropriations associated with the NCSL.

Include provisions of 2007 AB 350, creating a joint committee on state mandates.

Include provisions of SB 136, deleting the automatic distribution of the Wisconsin Statutes to enumerated state officers.

Include provisions of 2007 AB 205 requiring legislative approval of tribal gaming establishments.

Require six-year review of administrative rules.

Military Affairs

Delete current requirement department must require National Guard Tuition Grant participants to provide certain information.

Miscellaneous Appropriations

Delete one-time grants to Resch Aquatic Center in Green Bay; Town of Pensaukee for purchase of furniture, etc.; Firemen's Park in Sun Prairie; Southside Organizing Committee in Milwaukee; and, Greater New Birth, Inc. in Milwaukee.

Office of State Employment Relations

Delete provisions funding a labor-management cooperation program.

Delete provisions reassigning certain executive positions to new executive salary group levels.

Reduce sick leave benefit for new non-protective status state employees.

Public Defender

Delete funding and provision permitting the Public Defender to represent adults subject to involuntary civil commitment, protective placement or involuntary administration of psychotropic medication, without making a finding of indigency.

Regulation and Licensing

Delete JFC provision specifying a one-time \$5 credential fee assessment.

Supreme Court

Delete funding and auditor position for a standardized program for recording, reporting and auditing annual county court costs and revenues.

Delete provision related to federal grant for children's court initiative project.

Delete provision and funding related to justice initiatives coordinators position.

Delete provision to provide \$10,000 to implement a courthouse safety training program.

Delete provision modifying statutory language to allow the Director of State Courts Office to establish and charge fees for use of electronic filing of court documents under the circuit court automated information systems.

Veterans Affairs

Provide funding for a study of a new state veterans cemetery in Outagamie County.

Specify that non-resident service members killed in action may be buried in a state veteran's cemetery.

Include provisions of 2007 AB 80, gold star license plate eligibility.

Include provisions of 2007 AB 70, council on veterans program membership.

TRANSPORTATION AND PROPERTY TAX RELIEF

Public Service Commission

Repeal nuclear moratorium statute.

Require PSC report investigating alternative energy strategies.

Modify current law on PSC advocacy on nuclear storage issues.

Modify JFC provision repealing exemption of cell phone providers from Universal Service Fund provisions.

Place limits on Universal Service Fund contributions.

Direct audit of a least one program receiving funding from USF.

Delete JFC provision affecting hydro limitation under renewable energy portfolio requirements.

Office of Commissioner of Railroads (PSC)

Eliminate safety analyst position in Office of Commissioner of Railroads.

Shared Revenue and Tax Relief

Delete provision recommended by governor and JFC that would increase payments under the county and municipal aid program and reduce payments by a total of \$57.9 million. Decrease

payments to each county by 5%; decrease payments by 12.5% for municipalities with both 2007 populations exceeding 20,000 and 2007 county and municipal aid payments by \$250 per capita (Milwaukee, Racine, Beloit and Superior).

Modify current law provisions related to state aid payments to municipalities containing production plants.

Delete county aid fund recommended by governor and JFC.

Delete county levy restraint program recommended by governor and JFC.

Decrease funding for payments for municipal services to reflect a reduction in payments to the City of Madison.

Delete JFC provisions related to distributing \$100 million under a new first-dollar credit and instead increase current school levy tax credit distribution.

Delete homestead tax credit changes indexing the maximum income level, maximum property taxes, and income threshold formula factors; restrict credit to claimants 65 or older, married or have one or more dependents.

Replace levy limit for counties and municipalities proposed by the governor and modified by JFC.

Prohibit any technical college district from increasing its tax levy by more than a percentage to be determined through a formula.

Delete provisions adopted by JFC regarding the exemption of low-income residential housing from the property tax.

Provide a property tax exemption for restaurant kitchen equipment.

Modify property tax exemption for treatment plant and pollution abatement equipment (Newark Decision).

Require counties to distribute penalties assessed for converting agricultural land to another use to the affected municipalities within 30 days of receipt of payment.

Limit the scope of direct legislation.

Transportation

Eliminate the oil company assessment.

Increase vehicle registration fee schedule for heavy trucks by 15%.

Increase standard vehicle title fee to \$38.50.

Delete JFC provisions converting 16 appropriations in non-DOT agencies from GPR to SEG.

Delete JFC provision making the annual transfer to the Nonpoint pollution account of the environmental fund from the transportation fund instead of the general fund.

Delete JFC provision relating to transportation fund appropriation for supplementing general fund debt service.

Require transfer of sales tax on vehicles and related products to the transportation fund.

Place a restriction on use of transportation fund.

Establish a procedure for eliminating transportation fund deficit.

Require JFC review of allotment adjustments to DOT federal appropriations.

Reduce state share of funding of the Amtrak Hiawatha route.

Delete JFC provision providing \$32 million in additional general fund supported GO bonding for passenger rail service improvements.

Delete some funding for commuter rail service in JFC sub for preliminary engineering for the Kenosha-Racine-Milwaukee commuter rail extension project.

Eliminate aviation career education program.

Transfer funding from local transportation assistance grant programs to new appropriations for grants for bicycle and pedestrian projects.

Require DOT to provide a grant to the Village of Rib Lake for street improvements.

Increase funding to provide total increases of 4.9% in 07-08 and 2.2% in 08-09 for the state highway rehabilitation program.

Increase funding for the major highway development program and decrease revenue bonding authority.

Require DOT to include a major highway development project progress report in its semi-annual reports.

Require DOT to contract for a financial consultant to work on aspects of financing construction of the Stillwater Bridge, utilizing federal funds.

Require DOT to award a grant for Business Highway 51 widening project in Marathon County.

Delete 25 positions to reflect elimination of positions provided by JFC for preliminary work related to reconstruction of the Zoo Interchange.

Delete \$232,000 in 07-08 for printing of state highway maps and specify DOT may only print maps in one year of each fiscal biennium.

Require DOT to begin construction for STH major highway development project on STH 23 between STH 67 and USH 41 in Fond du Lac and Sheboygan counties by July 1, 2009.

Require DOT to start a reconstruction project on STH 13 (Division Street) in the City of Colby in 08-09.

Require DOT to compete a reconstruction project in the Village of Oregon on USH 14 between CTH MM and STH 138.

Prohibit construction of a truck weigh station in the Village of Rockland, La Crosse County.

Require DOT to use value engineering for highway improvement projects under certain circumstances.

Modify current law on prevailing wage provisions to state highway and building construction contracts and municipal construction contracts.

Require DOT to contract for a study of Wisconsin's truck size and weight laws.

Authorize municipality approve of access points to a controlled access state trunk highway under certain circumstances.

Delete provision in JFC substitute designating USH 8 in Barron County as the "Donald J. Schneider Highway."

Require DOT to designate and mark USH 14 from Wisconsin-Illinois border to Madison as the "Ronald Reagan Memorial Highway.

Delete provision in JFC sub eliminating two license plates.

Require DOT to maintain DMV service center in every municipality where a service center was located as of Dec. 1, 2006, with exceptions.

Treat organ transplant vehicles as authorized emergency vehicles.

Authorize vehicle immobilization and impoundment for repeated parking violations.

Adopt provisions of 2007 AB 89, operating an aircraft while intoxicated, as modified.

Modify JFC provision requiring a \$75,000 grant to a motorcycling organization for a "rider-to-rider" campaign.

NATURAL RESOURCES AND COMMERCE

Agriculture, Trade and Consumer Protection

Delete %1,785,200 GPR annually from standard budget adjustment.

Eliminate \$0.75 tipping fee and the \$2 increase in the motor vehicle title transfer fee.

Transfer \$3,650,000 GPR annually to the nonpoint account.

Increase funding of \$3 million for local nutrient management planning grants.

Require DATCP to develop a plan to increase producer access to trained private sector technical service providers, and utilization of those providers, for the development and implementation of nutrient management plans.

Provide \$2,500,000 recycling fund SEG in a biennial appropriation; require WHEDA to transfer \$2,500,000 in unencumbered reserves to DATCP for deposit in the biennial PR appropriations. Direct DATCP to award a grant to the first pulp and paper mill to be free of natural gas and coal usage in Wisconsin.

Provide DATCP with \$4 million recycling fund SEG to make grants for the construction of soybean crushing facilities.

Makes changes to the agriculture chemical cleanup program fund fee reductions.

Delete the grants to the Dane County Exposition Center.

Change the funding source for the Discovery Farms project.

Delete the Joint Finance provision relating to the Office of Privacy Protection.

Delete the Joint Finance provision relating to revenue and position adjustments.

Sunset the current agriculture producer security program.

Increase the assessment under the current marketing order for corn from \$0.01 per bushel to \$0.05 per bushel. (AB-306, Asm. Am. 1).

Require DATCP and DHFS to prepare a plan for the consolidation for their respective food safety programs into a single food safety program administered by DATCP.

Eliminate the statutory authorization for the World Dairy Center Authority.

Specify that new or renewed contracts between fuel suppliers and fuel retailers entered into may not restrict the ability of a fuel retailer to sell or install equipment to dispense E85 or B20.

Require DATCP to prepare a report on the manners in which incentives could be used to promote the modernization and expansion of cooperative dairy manufacturing facilities.

Allow municipalities with a population over 5,000 people to contract for local weights and measures testing and inspection.

Commerce

GPR Base Level funding reduction: \$3,962,500 (10%) and 4.0 GPR positions.

Repeal the private sewage system grant program.

Reduce funding for the Wisconsin Development Fund by \$1,419,600.

Delete funding placed in the Joint Finance supplemental appropriations for Forward Wisconsin and the Dept of Commerce plan to attract business to Wisconsin.

Eliminate the American Indian liaison position.

Specify the state could not provide funding for a venture center unless established as a non-governmental organization with a mission to facilitate access to venture capital for Wisconsin-based businesses.

Eliminate and consolidate a number of Dept. of Commerce and other agency financial and technical assistance programs and reports.

Include the Governor's recommendation, not JFC, to transfer WHEDA unencumbered reserves to Commerce for housing programs.

Delete JFC provision increase funding for the diesel truck idling reduction grant program.

Direct Commerce to prepare a report on PECFA sites and private insurance.

Direct that, in each year in which petroleum inspection revenue obligations are outstanding, DOA and Commerce shall periodically determine whether the balance is the petroleum inspection fund exceed the amount necessary to make all expenditures and DOA shall retire outstanding obligations.

Delete grant to Crex Meadows Youth Conservation Camp.

Delete the requirement that all building permits be displayed in the same location on a building site.

Include AB-229, which would eliminate the prohibition on heated exterior pedestrian walkways.

Change the requirements for automatic fire sprinkler and fire resistance building materials in multifamily dwellings and community-based residential facilities.

Include Asm Sub Am. 1 to AB-358, which makes changes to the regulation of elevators.

Natural Resources

Departmentwide

Standard budget adjustments: delete an additional \$662,900 GPR annually for adjustments to base.

Reduce the amount provided annually for DNR facility rental costs across the state.

Delete the regional environmental analysis and review specialist positions used to expedite the environmental analysis of local governmental transportation projects.

Change the funding for the grant to Florence Wild Rivers Interpretive center to the forestry account rather than GPR.

Delete the \$1.05 billion Stewardship reauthorization; rather provide \$145 million general obligation bonding revenues for Stewardship for an additional 10 years.

Reduce the total general obligation bonding authority authorized for stewardship by \$2.05 million.

Require JFC to review projects under Stewardship through the 14-day passive review process' specify all projects in excess of \$500,000 would be subject to review.

Require public access to stewardship land to be open for public hunting, fishing, trapping, hiking and cross-country skiing.

Specify that no more than 10% of Stewardship funds may be used to purchase parcels less than 10 acres in size.

Request Legislative Audit Bureau to conduct an audit of the Stewardship program.

Include the JFC provision on Stewardship earmarks.

Direct DNR to conduct a comprehensive evaluation of the Stewardship program.

Specify that \$200,000 in 2008-09 for operations and maintenance expenses on properties managed by the Bureau of Facilities and Lands be one-time funding.

Fish, Wildlife, and Recreation

- Reduce the maximum amount appropriated from the endangered resources funding.
- Specify if revenues are not sufficient in the wildlife damage program funding for the control of wild animals would first be reduced or eliminated before other program activities were reduced or eliminated.
- Provide \$15,000 annually for estimated venison processing donations.
- Provide 205 warden radios.
- Delete annual increase to the environmental fund for additional LTEs.
- Require a permit for shovelnose sturgeons and eggs.
- Provide one-time funding for grants to the Wisconsin chapter of the National wild Turkey Federation.
- Provide that an annual community event which is sponsored by a municipality or sportsmen's club are exempt from the requirement to obtain a permit from the DNR in order to take from the wild or possess live native wild reptiles.
- Delete the study to reduce the seagull population in Wisconsin.
- Delete the hunter mentorship program.
- Allows for loaded weapons in vehicles.
- Authorize a municipality to issue a boat launch fee to fund rescue boat operations.
- Provides an exemption from the motorboat noise limits for airboats being used by license trappers.

- Reduce funding to counties for ATV law enforcement patrols.
- Reduce funding for Northern state forest ATV trails.
- Provide grants for lightweight utility vehicles pilot program.

Forestry and Parks

Allow a municipality to retain closed acreage payments under the Management Forest Land program.

Delete increases in the parks and southern forest operations.

Delete the funding increase for operations at Milwaukee Lakeshore State Park.

Delete the authority for DNR to award forestry resource and development grants to match federal monies for forestry biomass grants.

Water Quality

Increase funding for aquatic invasive species grants.

Air, Waste, and Contaminated Land

Delete the \$3 per ton recycling tipping fee increase.

Delete the transfer from the recycling fund to the general fund.

Delete the increase for the waste reduction and recycling demonstration grant program.

Delete the \$0.35 per ton increase to the solid waste tipping fee for waste other than high-volume industrial waste.

Include the provisions of SB-202, allows municipalities to issue bonds to secure a loan or grant from the DNR brownfields revolving loan program.

State Fair Park

Restore \$4.3 million in existing authorized but unissued program revenue-supported bonding authority for the State Fair Park.

Tourism

Provide additional funding for aid in lieu of property taxes made to the Kickapoo Valley Reserve.

Other Provisions

Modify the law related to immunity from recreational land liability.

Include SB-402, remedies against manufacturers, distributors, sellers, and promoters of products.
